

White Haven, 1.5 mi SW. of RR. station, along U.S. Highway 940 to Y-rd. junction with County Road 40118, thence 4.0 mi S. along Road 40118 to County line (Road number changes to A 1012), continue 1.2 mi along Road A 1012 to crossroads, thence 1.1 mi left along County Road 13023 to rd. on right (entrance to Carbon County Home) and graveled rd. left, thence 1.1 mi left along graveled rd. to residence of Mrs. M. W. Reifon, thence right along driveway passing to right of house and continue 0.1 mi along field rd. to woods corner; 52 ft NW. of centerline of rd. at field corner; 30 ft N. of edge of woods; 30 ft W. of edge of woods; in concrete post projecting 6 in.; standard tablet stamped "ET 4 CRH 1963"
